Here you'll find all the answers to your questions regarding the current health protocols, and the measures we have undertaken to guarantee your safety. These may change as new regulations are put in place. They will be updated as necessary, so do not hesitate to refer back to them regularly.

**THE SAFE & CLEAN LABEL: A RIGOROUSLY APPLIED AND GUARANTEED HEALTH PROTOCOL**

We are pleased to inform you that, since 2020, all our venues and business activities have obtained the "Safe and Clean" label issued by APAVE. This certificate guarantees the quality of all the protocols applied, proposed and deployed in our venues, at our events, or during our teams' production and assembly operations.

**IF YOU ARE GETTING READY TO TRAVEL TO ATTEND IN THE SHOW.**

Please note that you can only enter the country if you have a negative PCR test taken within the past 48 hours. It takes at least 24 hours to get the results of this test.



**A HEALTH PASS IS YOUR KEY TO ENTERING THE SHOW**

A 'Health Pass' is required in order to enter the show. You must have one of the documents listed below:

- **Proof of a negative RT-PCR or antigenic test that is less than 48 hours old**
- **A serological test or certificate of infection** that is more than 15 days but less than 6 months old, proving a prior coronavirus infection. This certificate is only valid for a period of six months from the date of the examination or test,
- **A certificate of full vaccination**, with one of the vaccines granted a marketing authorization by the European Medicines Agency:
  - For the vaccine « COVID-19 Vaccine Janssen », **28 days after the administration of one dose**,
  - For the other vaccines, **14 days after the administration of a second dose**, except for persons who have been infected with COVID-19, for whom this period commences after the administration of one dose.

Please note: Self-tests are not valid for entry to the show.

> **The Health Pass will be requested and verified by "health monitors"** stationed outside the show's entry halls.

> **For those who have been unable to get an antigenic test prior to their arrival at the show, a testing station will be located in front of the entrance** (results in 15/20 minutes).

> **The entry badge to the show is entirely digital. Please remember to pre-register before coming.**

> **Preventive measures remain in place:** a minimum width of 3 meters in the aisles; mandatory wearing of masks; hydro-alcoholic gel made available...

> **No checkroom facilities will be available**, luggage is not permitted in the halls.

> For foreign travelers who require a PCR test to return home, please note that a Health Pass Test area is available on site to perform an Antigenic (20 minutes) and PCR Test.

A standardization of European QR codes and documents is underway, for those who are unable to generate official documents with QR codes: for example, if you have been vaccinated by a doctor, you will need a certificate from the doctor. For those residing in France, these documents can be downloaded in the "Tous Anti Covid" app.

#### **Where will health passes be checked?**

The health pass in your possession will be requested by "health monitors" outside the show's entry halls: this will be a visual inspection and/or via an app that can read the QR Code information, thus allowing you to enter the show.

If you do not have the required documents, a Sanitary Pass Test area is available on site to perform an Antigenic Test (20 minutes).

#### **SHOW ENTRY BADGES ARE NOW ENTIRELY DIGITAL**

You will not be given any physical badge! Badges are now completely digital. Remember to pre-register and bring the QR Code you received with your registration, you will need to present it at the entry.

#### **WHAT HEALTH MEASURES ARE IMPLEMENTED AT THE SHOW?**

##### **Regarding capacity limits at the Grand Palais Ephémère :**

Regarding the authorized capacity limit of the Grand Palais Ephémère, there is good news!

As of June 30, no other limit is required other than that regularly applicable in establishments open to the public. At the moment, that is 9,300 people at any given time. However, in order to guarantee the comfort of this event, which is reserved exclusively for professionals, we intend to welcome no more than 2,000 people at any given time. We will therefore be well below the thresh-hold of people we could actually accommodate.

#### **PLEASE NOTE:**

##### **✓ NO CHECKROOM**

The absence of a checkroom is part of the sanitary measures required for events: we therefore do not provide any place where you can leave your belongings.

##### **✓ TRAFFIC FLOW**

The configuration of the aisles - at least 3 meters wide - will enable the respect of social distancing and preventive measures that, as an added caution, remain in effect.

##### **✓ WEARING A MASK AND HYDRO-ALCOHOLIC GEL**

As you know, wearing a mask remains compulsory and we will make hydro-alcoholic gel available during the show. Signage recalling the precautionary preventive safety gestures will be posted on the site for all to see.

##### **✓ ON THE STANDS OF YOUR EXHIBITOR PARTNERS**

Food distribution and coffee machines are not allowed in the stands: your preferred partners will be unable to offer you a coffee or other treat, so don't blame them! Nevertheless, we will provide a catering service as well as coffee and drinks in a dedicated area of the show, with tables and chairs at your disposal.

##### **✓ NO PAPER DOCUMENTS PROVIDED AT THE VENUE**

We will not be distributing a paper map or guide at the venue. All information about the show, including the list of exhibitors, their offer of materials, and their new products, can be found on our website, especially under the sourcing tab, for access to the Première Vision Marketplace.

✓ **A REQUIRED SANITARY MEASUREMENT COORDINATOR AT PREMIERE VISION AND ALL OUR EXHIBITORS**

We are all affected by all these protective measures, so each company participating in the event will have designated a coordinator to ensure compliance with the rules in force, including Première Vision.

**IF YOU WILL BE TRAVELLING ABROAD AFTER THE SHOW TO RETURN HOME: A HEALTH CONCIERGE SERVICE IS AVAILABLE TO HELP YOU GET YOUR PCR TEST**

We have put in place, for you, an exclusive health test service. This service will allow all our partners, exhibitors and visitors who will be traveling outside of France some 24-hours later or more.
